1. CNP Lunch/Breakfast Application and Policy Statement for 2014-2015
2. Lunch and breakfast prices will remain the same as last year for students, employees, and visitors. Prices will be as follows:
 - Breakfast – students at West Elementary, Russellville Elementary & Russellville Middle – no charge
 - Breakfast – Students at Russellville High School - \$1.00
 - Lunch – Students at West Elementary & Russellville Elementary - \$1.75
 - Lunch – Students at Russellville Middle & High School - \$2.00
 - Reduced price for breakfast – students - \$.30
 - Reduced price for lunch – students - \$.40
 - Employee Lunch - \$2.50
 - Employee Breakfast if not helping with Universal Breakfast - \$1.25
 - Visitor Breakfast - \$1.50
 - Visitor Lunch - \$4.00
 - After-school snacks will be provided at no costs to all organized student activities at all four schools during the 2014-15 school year
